## ENTRY REQUIREMENTS

- For local students, at least CGPA 2.50 Matriculation/Pre-University or STPM with at least Grade C+ (NGMP 2.33) in any two (2) subjects (not including General Studies), and
- Obtained at least Grade C during SPM in Mathematics/ Additional Mathematics subject, and
- Obtained at least Grade E during SPM for the English Language subject, and
- Obtained at least Band 2 in the Malaysian University English Test (MUET)
- For international students, a minimum IELTS Score of 5.5 or its equivalent (e.g TOEFL paper-based test -550; TOEFL Computer-based Test -213; TOEFL Internet-based Test 79-80)
- Other equivalent qualifications approved by the University Senate

## COURSE FEES

Malaysian student **RM62,228.00**

International student **RM86,240.00**

The fee is to be paid in eight (8) semesters. Students will have to pay further administrative fees and recurring fees if they extend their studies.

Students are entitled to apply for PTPTN at only 1% interest rate to cover the course fees. Alternatively, they can apply other external scholarship or education loan for undergraduate programme.
